Sweepstakes Rules ("Official Rules")

No purchase, payment, or consideration of any kind is necessary to enter or win this promotion. A purchase or payment to Moogsoft or the DevOps.Js organizers will not affect Your chances of winning.

- 1. **Description**: Moogsoft's sweepstakes (the "Promotion") at the DevOps.Js (March 29-30, 2021), described in further detail at: https://info.moogsoft.com/devopsjs-mar21-giveaway.html, is sponsored by Moogsoft, Inc. ("Moogsoft"). Moogsoft invites eligible individuals (individually, "You" or "Your," collectively "Entrants") to submit an entry to the Promotion. One (1) winner will be selected in a random drawing from all eligible entries received. The Promotion is subject to all applicable laws and regulations and is void where prohibited.
- 2. **Eligibility**: The Promotion is only open to legal residents of the United States as of the date of entry. The Promotion is not open to any employee of a current Moogsoft customer or any employee of a competitor of Moogsoft. In addition, the Promotion is not open to any agent/contractor/student/employee of Moogsoft or its affiliates or marketing firms, or to any immediate family or household member of those individuals.
- 3. **Promotion Timeframe**: The Promotion entry period begins on Monday, March 29, 2021, at 7:00 a.m. Pacific Daylight Time and ends on Wednesday, March 31, 2021, at 5:00 p.m. Pacific Daylight Time (the "Promotion Period"). Moogsoft is the only determinant for the purposes of a valid submission in the Promotion and Moogsoft's clock is the official clock.

4. How to Enter:

- a. <u>By Signing Up for a Free Trial of the Moogsoft Observability Platform</u>. You will automatically be entered in the Promotion if You visit https://info.moogsoft.com/devopsjs-mar21-giveaway.html during the Promotion Period and follow the directions for Promotion entry, which includes (i) signing up for a free trial of the Moogsoft Observability Platform, (ii) deploying the collector, and (iii) connecting an integration platform.
- b. <u>By Signing Up on the Moogsoft Website</u>. You may submit an entry for the Promotion by visiting https://www.moogsoft.com/request-trial-express/?utm_source=devopsjs&utm_medium=event&ut m_campaign=7013V0000009fwb. On that form, You will be asked to enter Your first and last name, organization, email address.
- c. <u>Publicity</u>. You may opt-out of allowing Moogsoft to use Your name and likeness in promotional materials regarding the Promotion. The choice to opt-out will appear on the sign up and/or entry forms.
- d. <u>Valid Entries</u>. For You to be entered into the Promotion, the You must either sign up for a free trial of the Moogsoft Observability Platform as specified in Section 4(a) or complete an online entry form as specified in Section 4(b). All entries must be received by the Moogsoft during the Promotion Period. You understand and agree that submitting an entry does not mean You will win the Promotion. Incomplete entries may be disqualified. All entries submitted become the property of

Moogsoft and will not be returned. Only one entry to the Promotion is allowed for each Entrant. If an entry has inaccurate information or is missing Your name or email address, such entries shall be void. In the event of a dispute as to the identity of an Entrant, the authorized account holder of the the email address used to enter will be deemed to be the Entrant. 5. Drawing, Notification, Verification, Disqualification and Forfeiture, and Shipping:

- a. <u>Drawing Time and Location</u>. Promotion winner (the "Winner") will be selected on Wednesday, April 14, 2021, at 10:00 a.m. Pacific Daylight Time, in a random drawing from among all the eligible entries received. - b. <u>Notification</u>. Notification of the Winner shall occur on or before 5:00 p.m. Pacific Daylight Time on April 14, 2021. It is Your sole responsibility to ensure that Your contact information is correct at time of entry. Moogsoft will not be able to change or update contact information once an entry is made.
